

Gen Con 2018 Art Show Juried Submission Prospectus

This document applies to Gen Con Art Show

The Gen Con Art Show is the premiere industry showcase for artists in the fantasy, sci-fi, horror, and gaming genres. Gen Con 50 was the ninth consecutive year of record turnstile attendance, reaching 207,979. The quality of the Art Show has made it a "must see" part of the Gen Con experience.

Applying to the Gen Con Art Show is a juried process, any artist interested in applying will need to submit an entry to be reviewed by an anonymous jury.

PRICING

Submission Fee (non-refundable)\$25Two-Panel Table\$490Four-Panel Table\$655

- The cost of the table is for the entire four (4) days of the convention.
- There are two choices of tables: four-panel or two-panel. Tables are 23" wide, a two-panel table is 6' long, a four-panel table is 8' long. Tables are skirted. Your table choice has no influence on the selection process.
- Half tables are not available. Sharing tables is not allowed.
- Table price includes two (2) complementary "Exhibitor" badges, one for the Artist and one for an assistant.

SUBMISSION GUIDELINES

- 1. Submissions are only accepted online through Entrythingy.com. Paper submissions are not accepted.
- 2. You must have an account in entrythingy.com and gencon.com.
- 3. There is a submission fee of twenty-five (\$25) dollars. Fee is non-refundable whether or not artist is accepted into the Gen Con Art Show.
- 4. Artist must submit three (3) different pieces of their work including title, medium, and dimensions. Work submitted must represent the artwork Artist intends to show/sell at the Gen Con Art Show. Images should be of good quality and give the jurors an idea of who you are and your point of view.
 - o Image upload sizes are: Max file size of 5MB; min file size of 100kb; min size width of 500px
 - Image file types accepted: jpg, gif, png
- 5. Artists will be notified either way.
- 6. Accepted artists will be required to fill out a registration form; form will be emailed along with their acceptance notification. The registration form must be filled out, signed, and returned along with full payment by the Registration Deadline date.
- 7. If artist's registration form is not received by the deadline date, artist will forfeit entry and will no longer be considered a participant of the Art Show.

GENERAL POLICIES (Please read the Appendix B: Rules & Regulations document for all the information)

- 8. All work must be the creation of the potential exhibiting artist and should relate to fantasy, science fiction, horror, or the adventure gaming industry.
- 9. Craft artists are prohibited. Craft art includes but is not limited to: jewelry, costume items, masks, ceramics, stained glass, and toys.
- 10. Only the registered artist may sell the work; no retailers are permitted in the Art Show.
- 11. Attendance at Gen Con is required in order to display work/sell merchandise; Artist must be present and attend the show for all four days.
- 12. A Gen Con account is required in our system in order to participate in the Art Show. You can create an account at any time if you currently don't have one. If you already have a Gen Con account, you do not need to create a new one.
